

## SUMMARY

**Topicality of the Research.** The situation with the consumption and distribution of drugs is one of the intractable problems of contemporary international and national politics. Drug trafficking is accompanied by active involvement in the addiction of a certain part of social groups, reinforcing the dangerous trend of drug addiction in Russian society. This has resulted in a destructive impact on the legal system, political-legal, socio-economic, the moral foundations of the state.

Despite the efforts made, still not the necessary system of combating drug abuse that combines a balanced set of preventive, medical and rehabilitation measures.

**Objectives of the Research** are a study of process of realization of public antinarcotic policy at regional level and development of corresponding recommendations on his perfection.

**Research tasks:**

- to consider theoretical bases of research of public antinarcotic policy of Russian Federation;

- to conduct the analysis of practice of realization of public antinarcotic policy at regional level and define the ways of her perfection (on the example of The Republic Of North Ossetia-Alania).

**The Theoretical and Practical Significance of the Research.** Conceptual provisions of the study to develop theoretical ideas about the nature of the system of comprehensive rehabilitation and resocialization of drug users as a priority directions of the state anti-drug policy. In addition, the findings and practical recommendations developed in the study can be used as in the work of public authorities of the Republic of North Ossetia-Alania, and in the activities of other authorities involved in the implementation of anti-drug policy at the regional level.

**The Findings of the Research.** Today, the drug situation in the Republic of North Ossetia-Alania can be described as a complicated, but controlled. In order for the suspension of narcotization of the population, posing a threat to public health, economy, good order and security of the Republic of North Ossetia-Alania, has been developed the State programme of the Republic of "Comprehensive measures on prevention of illegal consumption of psychoactive substances, rehabilitation and re-socialization of people who use psychoactive substances without a doctor's prescription for 2015-2017".

However, the lack of established mechanisms in the reintegration of individuals who have completed rehabilitation programs, and ensuring their employment is one of the problematic issues of formation of the regional segment of the National system of comprehensive rehabilitation and resocialization.

**Recommendations.** Ensuring employment of persons who have successfully completed a rehabilitation program, may contribute to the implementation in the framework of the regional program of assistance of employment of the population of targeted measures for the reduction of periods of job search and employment and vocational training of these persons.

It is important to study the successful experience of a number of constituent entities of the Russian Federation (Yamalo-Nenets Autonomous district, Sverdlovsk region, Krasnodar territory) in the field of employment of persons who

have undergone the liberation from drug addiction, with a view to its implementation in the Republic of North Ossetia-Alania.
