

## Summary

**The theme of the final qualifying work:** The formation of the values of family culture in non-governmental public organizations among the Russian youth.

**The relevance of the research:** Modern society is subject to the influence of individualism, the family and everything related to the relationships and processes occurring within this social institution are an important part of every person's life. The pace of modern socio-economic changes does not allow the younger generation to concentrate on constructive issues of building family relations and preserving family values. The mass media actively propagandize the idea of the viability of "civil marriages", implying the joint living of young people who do not formalize their relations. Thus, in the minds of young people an understanding is formed that "civil spouses", in fact, cohabitants, do not have special obligations to each other, which allows such spouses to refuse to conduct joint life at any moment. There are also serious concerns about the emerging trends among young people that are associated with the birth of children. Young people on purpose refuse to give birth to children, joining the "child-free" movement, which is gaining popularity in Western countries. The rule "one family - one child" is another trend among young families, which has a very negative impact on the demographic situation in our country.

We believe that with the development of modern trends which have a significant negative impact on the development and preservation of traditional family values, society is in danger of being in conditions of social degradation and depopulation. These disturbing facts are a cause of concern to ordinary citizens, communities and the state.

In his address to the citizens of Russia, the President of the Russian Federation regularly focuses on issues related to the support of young families and the implementation of family policies, notes the importance of the family in the processes of harmonious development of a healthy traditional society in the country. In the Address to the Federal Assembly on December 12, 2013, V.V. Putin stressed that "the destruction of traditional values leads to negative consequences for societies and is fundamentally anti-democratic," noted that traditional family values are "the spiritual, moral basis of the civilization of each nation."

The state family policy of the Russian Federation is a unified system of actions and principles that study the family as a social institution in the legal, organizational, economic, scientific, information aspect. In accordance with the Presidential Decree, the family policy is implemented by legislative and executive authorities of all levels, public associations, religious communities and organizations, political parties, trade unions, etc. Non-governmental and non-profit organizations carry out their activities to solve family problems in parallel with state structures. Their activities are aimed at providing financial support and assistance to the family by attracting sources of funding in the form of donations, subsidies and grants, grant payments for the implementation of projects aimed at social assistance to the family. Nevertheless, the social activities of nonprofit organizations in relation to the family institution in Russia are poorly developed.

The relevance of work on the formation of traditional family values on the basis of non-profit organizations is justified by the fact that the construction of civil society implies the participation of public institutions and the non-profit sector which activities are based on active citizenship. That is why the implementation of programs for the formation and development of traditional family values of young people should become a priority for the propaganda, research, educational, practical activities of non-profit organizations in our country that actively interact with state authorities at the present stage of development.

**The aim of the research:** to determine the degree of participation of non-governmental non-profit organizations in the issue of the formation of traditional family values among young people, by developing an effective tool for monitoring and educating young people by analyzing scientific facts and empirical data.

**Objectives of the study:**

- to study the methods of formation of worldview of modern youth;
- to consider theoretical and methodological approaches to the study of the modern family;
- to determine the features of the formation of traditional family values as an object of scientific analysis;
- to analyze the resource of non-profit organizations in the field of civil society development and family policy in the Russian Federation;
- to determine the degree of involvement of non-profit non-governmental organizations in the issue of the formation of traditional family values among modern youth;
- to develop the author's toolkit that fosters the formation of traditional family values among young people.

**Theoretical significance of the research:** the study, analysis and propaganda of traditional family values among young people, reflected in the monograph, scientific articles of the author of the project will create a unique theoretical basis for researching marriage preferences of young people, as well as analysis of the influence of traditional family values on modern youth.

**Practical significance of the research:** the implementation of the assigned tasks of the final qualifying work will be an active step in the process of formation of traditional family values among young people and popularization of the family institution as the basis of civil society and self-realization of the individual within the framework of non-profit public organizations.

**The results of the study:** The database "Features of wedding ceremonies of the peoples of the North Caucasus" was created and registered in the system of the Federal Service RosPatent. The scenario of the orientation seminar "Family values

and traditions in the minds of students" was developed and put into practice of the methodical activities of the non-profit organization "Unity". The scientific and innovative project "Peculiarities of wedding ceremonies of the peoples of the North Caucasus" became the laureate of the II degree at the annual competition of youth scientific and innovative projects "Innovative potential of university youth" in the category "Pedagogical Sciences".
