## **Summary**

The theme of the final qualifying work: Social technologies of rehabilitation of drug addicted citizens in non-governmental organizations

The aim of the research: to investigate social technologies for the rehabilitation of drug dependent citizens, including those carried out in non-state institutions to develop recommendations for their improvement

Relevance of the research: is due to the fact that in modern Russia there is an increase in the number of social deviations, and the use of narcotic substances becomes especially threatening. The devastating effects of people's dependence on drugs are obvious: the aggravation of the criminal situation as a result of the need to extract funds for narcotic substances by various criminal ways; infection with serious diseases, including hepatitis and HIV infection; increased mortality among young people; the birth of children with various abnormalities.

All this led to the fact that one of the most important goals of the state policy of the Russian Federation today is the social rehabilitation and resocialization of drug addicts, including in non-governmental organizations.

## Theoretical and practical significance of the research.

Theoretical significance of the work lies in the fact that its results allow to develop and deepen theoretical ideas in the study of problems of social rehabilitation of drug addicted citizens.

The practical significance of the study is the possibility of using the proposed recommendations to improve the effectiveness of non-state organizations involved in the social rehabilitation of people with drug addiction.

The results of the study: Analysis of statistical data, publications of specialists, legislative initiatives has led to the conclusion that the Russian system of state institutions of narcological profile has demonstrated the inability to provide all the completeness of measures for the social rehabilitation of drug addicts. The

state began to interact in this activity with non-state organizations. Having studied the social rehabilitation programs for non-governmental organizations of the Stavropol Territory, we identified the main social technologies that are used in working with drug addicts such as psychological rehabilitation, churching, social rehabilitation, resocialization, physical recovery. One of the main problems we see is the lack of development for parents in the form of brief clear instructions that they can have at hand and which can be guided in case of suspicion that the child is involved in the process of searching, storing and taking narcotic drugs. In the Stavropol region, and especially in the towns of KMV group, statistics on the consumption of new types of drugs are growing, and "pharmacy drug addiction" is spreading. Parents, the state, society need to strengthen preventive measures.

**Recommendations:** As one of such measures we provide the project information brochure with a reminder to parents to ensure on time detection of drug addiction of the child and his/her social rehabilitation. The aim of the project is the creation of small-sized reminder with a very simple infographic, briefly telling parents what to look for in the appearance, health, child's behavior, so if in doubt, to be able to deal with such a difficult situation as the beginning of the addiction, and to render social and pedagogical support. Info-brochure memo will provide an opportunity to inform parents from the towns of KMV group about the level of danger that today threatens their children and give them information for social prevention of drug addiction among children. This will greatly improve the effectiveness of social work with addicted teenagers in the region.
