

Title: “Intra-word enantiosemia as a unity of opposites in the semantic structure of a word (based on the English language material)”.

Topical Importance is explained by the necessity of turning attention to the word content side for a deeper and more comprehensive analysis of this vocabulary layer, which has a high degree of use for pragmatic purposes. The choice of the topic as an object of study is due to the fact that this group of words has not yet been sufficiently analyzed. It is connected with the scientists’ opinion divergence on this phenomenon, in particular, with its name, the nature of its relations with other linguistic categories, with the place of enantiosemia in the lexical and semantic structure of the language.

Goal: to determine the connection nature between the phenomenon of “enantiosemia” and other linguistic categories, its place among them, and also to consider the semantic-pragmatic features of some parts of speech enantiosemia functioning in the context of a situation.

Tasks:

- to analyze the theoretical foundations of the "enantiosemia" concept;
- to determine the status of the "enantiosemia" linguistic phenomenon;
- to analyze the enantiosemia classification types, to characterize each type with an illustration of examples;
- to make a component analysis in order to select factual material as the evidence base of theoretical principles and the material basis for the practical part of the study implementation;
- to make a semantic-pragmatic analysis of verbal, substantive, gerundial, adjective, adverbial and interjective enantiosemia with the study of pragmatic

features of these lexical units speech functioning.

Theoretical and practical applicability. The theoretical significance of the study is to systematize the available linguistic material on the research topic, to integrate consideration of enantiosemia in the formal, semantic and pragmatic aspects. The data obtained during the study contribute to theoretical issues related to the study of meaning as a section of linguistics studying the meaning of words, their changes and internal structure. The analysis of the theoretical foundations and semantic-pragmatic features of parts of speech enantiosemia contributes to the further enantiosemia doctrine development.

The study results can be used in theoretical courses and seminars on general linguistics, lexicology, pragmatics, theory and practice of translation, lexicographic practice for fixing new meanings of already known dictionary units.
