**Topicality of the research:** At present, the role of social policy at all levels of management, including municipal formations is growing. **Recommendations:** In the complex of measures of social character the social adaptation of persons realized from penitentiary institutions is assuming ever greater significance. At the same time Pyatigorsk Lacks the system of complex social assistance to people who have completed their term. The program method of the solution of the indicated problem and realization of the required measures is seen as the most effective. The proposed program implies the realization, of measures to create the system of social rehabilitation of persons who have completed their term in imprisonment.
