

SUMMARY

Subject matter of the dissertation: The economic security ensuring of small businesses (based on the materials of Fantaziya LLC¹).

Topicality of the research. The small businesses are an important structural element of the national economy. The economy and social sphere cannot develop harmoniously without small enterprise. The small businesses' subjects create jobs, saturate the market with necessary products, and set the pace of economic growth. However, the small businesses face a variety of external and internal threats in the current reality that means financial, economic and political instability. The main task for small businesses in such conditions is to provide their economic security.

Objective: research of possibilities to provide the economic security for small businesses in modern Russian conditions.

Tasks: 1) to determine specifics of the economic security provision of small businesses; 2) to identify and systematize threats and risks to the economic security of small businesses; 3) to evaluate the activities of Fantaziya LLC as a small business company in the Stavropol territory; 4) to analyze problems in the field of the economic security provision of Fantaziya LLC; 5) to identify intra-firm opportunities to strengthen the economic security of a small enterprise Fantaziya LLC; 6) to offer lines of state support for small businesses in order to strengthen their economic security.

Theoretical significance of the research: the ideas about neutralizing of both known and potential threats to the small businesses' economic security and modeling of the security service can be applied to further research on strengthening the financial position and economic security of small businesses.

Practical significance of the study: the results of the study can be used in identifying threats to economic security and building economic security corporate systems for small businesses, in particular, Fantaziya LLC and similar trading companies.

Results of the research:

1) the specifics of ensuring economic security for small entrepreneurship's subjects are determined;

2) the threats and risks of the economic security for small businesses are identified and systematized;

3) the Fantaziya LLC's activities as a small business in the Stavropol Territory are assessed;

4) the analysis of problems in the field of ensuring economic security for Fantaziya LLC is carried out;

5) the intra-firm opportunities for strengthening the economic security of a small company Fantaziya LLC are identified;

6) the directions of state support for small business entities are developed in order to strengthen their economic security.

Recommendations. I. Intra-firm opportunities to strengthen the economic security of Fantaziya LLC: 1) the creation of its own department of economic security, where 3 sectors will function: juridical, financial and economic, information and technical ones; 2) the strengthening of actions on the most problematic blocks of the economic security system of the small company (financial, personnel and intellectual, information, technical and technological, and political and juridical security).

II. State support for small businesses in order to strengthen their economic security, including: 1) the improvement of the legal regulation of state support; 2) the strengthening of financial support of small business's subjects; 3) the providing of property support (including the development of business incubators); 4) the development of infrastructure services and solving of import substitution problems of products by Russian small businesses.
